**IMPORTANT INFORMATION FOR PROPRIETORS OF PRIVATE SECURITY  
AGENCIES OPERATING IN HARYANA.**

All Security Agencies operating in Haryana and applied for issuing license under Private Security Agencies (Regulation) Act, 2005 and Haryana Govt. Notification dated 31.8.2009 are requested to submit an affidavit as per draft indicated below, duly attested by Executive Magistrate, so that application/case can be made in order:-

**AFFIDAVIT**

- (1) That I am one of the partners/promoters/ share holders in M/s \_\_\_\_\_ private Ltd. Company which has applied for grant of license to engage in the business of providing private security through our agency named above.
- (2) That I have carefully gone through the provisions of Private Security Agencies (Regulation) Act, 2005 and the notification of the Haryana Govt. dated 31<sup>st</sup> August, 2009 and undertake that the information furnished by me is factually correct and nothing has been suppressed, concealed or distorted therein.
- (3) That I further undertake that the said Private Security Agency has no foreign equity or the total equity combined in respect of all the partners/promoters/ share holders is less than 49% and the actual foreign equity is \_\_\_\_\_ % of the total investment and my share in the foreign equity is \_\_\_\_\_ % out of my total contribution of \_\_\_\_\_ %.

- (6) That I undertake to abide by the schedule to the Act regarding the payment of wages Act, Industrial disputes Act and other Acts as laid down under the schedule to Section 13 (1) (j) of the Act.
- (7) That I undertake to give preference to the ex-servicemen, ex-para military, ex-police personnel, ex-home guards of the State of Haryana for their enrollment and training for deployment as private security Guards and supervisors.
- (8) That in case any information found to be incorrect or false my license to engage in the business of providing security shall be cancelled.
